# **Housing, Communities and Local Government**

Following Prime Minister Theresa May's Cabinet and Ministerial reshuffle in early January the Department for Communities and Local Government has been renamed the Ministry of Housing, Communities and Local Government. The Rt Hon Sajid Javid MP remains the Secretary of State and Lord Bourne of Aberystwyth remains the Minister for Faith.

#### **BBC Religion and Ethics review**

In December the BBC published a review of its Religion and Ethics programming and output, with the aim of re-assessing its role and strategy in this area, and reconsidering how best to deliver its public service mission in this respect. This includes a new commitment to reflect better the diversity and plurality of faith and belief in the UK today. Among its key recommendations are:

- to help the public develop its religious literacy;
- to expand coverage of religion in News output; and
- to broaden the reach of Religion and Ethics content to diverse audiences, including those aged under 45.

The report also says that the BBC will partner with other organisations to host a summit discussing the role that belief plays in British society, to be held every two years, and that it will is designating 2019 'A Year of Beliefs' when special programming and content will be featured.

#### **Government report on Cathedrals and their communities**

In December the then Department for Communities and Local Government published, 'Cathedrals and their Communities: A report on the diverse roles of cathedrals in modern England'. This followed a tour during 2017 of all 42 English Anglican cathedrals by Lord Bourne of Aberystwyth, Minister for Faith and Integration.

The report aims to highlight the positive contributions that cathedrals make to their communities in a range of ways. Inter faith work is among those aspects of cathedrals' contributions prominently highlighted. Examples include the holding of inter faith events, collaboration with other faith communities on social issues, and participation in programmes of inter faith work, such as Inter Faith Week.

# The Sussex Hate Crime Project - final report

The Sussex Hate Crime Project, carried out by the University of Sussex and funded by the Leverhulme Trust, has published its final report. The project examined the indirect impact of hate crimes, including "how hate attacks on members of a community affect the thoughts, emotions and behaviours of other members of that community."

Across 2013-2018 the project worked with individuals and organisations from two commonly targeted groups, Muslim people and Lesbian, Gay, Bisexual and Trans (LGBT) people, in an attempt to understand how indirect experiences of hate crimes impact on individuals, communities, and society in general. Among key findings in the report are: an increased sense of vulnerability in communities whose members had been affected by hate crimes; a build-up of anger and frustration; and a distrust of the criminal justice system. It also notes that the effect of hate crime goes beyond those who suffer directly, including in faith communities.

#### 2021 Census

The Office for National Statistics organised a 'Census, Population & Public Policy Forum' on 13 December to gauge views in the areas of ethnicity, gender identity and sexual orientation ahead of the 2021 Census. Among the topics discussed was whether the question about ethnicity should include tick-box options for Sikhs and/or Jews – with views offered in both directions – and the importance of ethnicity and religion data being collected by service providers across central and local government to ensure that the needs of different communities are met at all levels.

The Office for National Statistics is carrying out a wide range of activity in preparation for the 2021 Census. This includes a range of consultative exercises alongside ongoing meetings of its Census Advisory Groups.

## 'Opt-out' consent for organ donation

People who donate their organs and tissue after they die help save many lives in England each year. However, 3 people die a day because of a lack of suitable organs.

There has been significant work with and by faith communities about organ donation, including development of materials about this and campaigns to raise awareness of the importance of donation.

IFN has highlighted the issues in various contexts, most recently the inclusion of a dedicated workshop at its National Meeting last July with Angela Ditchfield, Diversity Lead Nurse, Organ Donation & Transplantation, NHS and Kirit Mistry, Co-Chair, National Black, Asian and Minority Ethnic Transplant Alliance and NHS Blood and Transplant used Inter Faith Week 2017 to campaign to raise awareness

Although 8 out of 10 people say they would want to donate their organs and tissue after their death, most people never register to be organ donors. Under current rules in England, a person who has died can only be an organ donor if they have agreed to it when they were alive or has appointed a person to make a decision after their death. This is called giving consent. The government believes that it would increase the number of organs donated and save more lives if the law was changed so that people who do not want to donate their organs after their death would have to opt out. It plans to change the law in England.

On 12 December the Department of Health launched a consultation to find out what people think about proposed changes in which people are considered willing to be an organ donor after their death, unless they have 'opted out'. It is particularly interested in views on:

- how much say families have in their decease relative's decision to donate their organs;
- when exemptions to 'opt-out' would be needed, and what safeguards would be necessary; and
- how a new system might affect certain groups depending on age, disability, race or faith.

The consultation notes, at Section 4.3, that the Organ Donation Taskforce considered the attitudes of different faith and belief groups towards an opt-out system of consent and that its work highlighted significant reservations from people of certain faiths about the impact of moving to an opt-out system of consent, particularly for people less comfortable with the prospect of the change. It includes a question about whether the intended change could have a negative impact on people from some religious groups or ethnic backgrounds.

Scotland is also planning to move to an 'opt out' system, with the next step being for the Scottish Parliament to consider legislation in the coming parliamentary year <a href="http://www.bbc.co.uk/news/uk-scotland-42521772">http://www.bbc.co.uk/news/uk-scotland-42521772</a>

Following a detailed examination of all aspects of soft opt-out systems the Northern Ireland Assembly decided in 2016 not to proceed with specific legislation to introduce a soft opt-out system as a possible means of increasing levels of organ donation in Northern Ireland. However, the Assembly in recognition of the importance of promoting organ donation, passed legislation which places a statutory duty on the relevant Department to promote transplantation and increase awareness about transplantation and the donation of human organs.

#### **Faith and Mental health**

A number of faith and inter faith organisations are also involved in work relating to mental health issues, including dementia. Some examples of this work are included here.

## **Commonwealth Heads of Government Meeting**

The Commonwealth Heads of Government Meeting will take place in London and Windsor in the week of 16 April.

Leaders from more than 50 countries are expected to attend the summit, coming together to reaffirm common values, address global challenges and agree how to work to create a better future for the citizens of the Commonwealth, particularly young people. The Cabinet Office is supporting the meeting. It is in conversation with faith communities about the CHOGM programme and would like to encourage widespread involvement from faith and inter faith bodies as part of the wider involvement across society.

This Inter Faith Network programme was begun in October 2017 and will lead in July 2018 to publication of a new edition of IFN's youth inter faith action guide *Connect: Different Faiths, Shared Values* <a href="https://www.interfaith.org.uk/resources/connect-different-faiths-shared-values">https://www.interfaith.org.uk/resources/connect-different-faiths-shared-values</a>. It will also feed into a special youth-focused National Meeting of IFN in July.

## Heritage Lottery Fund Consultation on Strategic Funding Framework 2019-2024

The Heritage Lottery Fund uses money raised by National Lottery to invest in the full breadth of the UK's heritage. It is seeking thoughts on its strategic direction and proposals from as wide a range of stakeholders as possible, to help it set its priorities for how to use National Lottery Good Causes income for the period 2019-2024.

The consultation will opening shortly. #### **HMCTS consultation - Fit for the future: transforming the Court and Tribunal Estate**

Her Majesty's Courts and Tribunal Service began a consultation on 18 January about the transformation of the court system. The consultation is called: Fit for the future: transforming the Court and Tribunal Estate and closes on 29 March.

There are ten questions over all and one that specifically relates to people of religion and belief. Question 9 asks: "What is your view on how these proposals are likely to impact on groups of court and tribunal users with particular protected characteristics as defined in

the Equality Act 2010? Are there any sources of evidence or research that you think we should consider?".

Communities or individuals may respond to this as part of the wider consultation to ensure that where members of their faith communities have to go to court their religious requirements are met appropriately and with sensitively. This may include, for example, access to an appropriate Sacred Text when it comes to taking an oath or access to facilities for prayer.
